The **Livestock Marketing Information Center** (LMIC) began over 60 years ago. It is a North American cooperative effort involving 28 U.S. Land-Grant University Extension programs, six USDA agencies, and associate industry and educational organizations. Associate members include both U.S. and Canadian institutions. Our mission statement is "provide timely and comprehensive livestock marketing resources through cooperation". The LMIC is a non-advocacy virtual center of excellence. Commodities/sectors focused on are cattle/beef; hogs/pork; sheep/lamb; dairy; poultry; and feedstuffs.

Staff continuously produces unbiased and science-based materials to strengthen and supplement education and research activities of cooperating institutions. In particular, specialists at the Center conduct applied market analysis and staff maintain a comprehensive database. The LMIC maintains a website (www.lmic.info) and uses other forms of electronic distribution.

This position is supported by a combination of funds from the participating cooperating institutions and is administered by Colorado State University Extension. The position is located in Lakewood, Colorado, a suburb west of Denver and located on the eastern slope of the Rocky Mountains. Several Federal and state government agencies are located in the area. Key agricultural organizations and industries are located in Denver. The metropolitan area is an important regional center for transportation and recreation as well as cultural activities.

<u>PURPOSE OF POSITION</u>: This position assembles, analyzes, reports and publishes economic outlook and marketing/management information related to the livestock and feedstuff industries.

## **Economic Analysis, Development and Distribution 70%**

- Conducts market analysis including situation and outlook.
- Writes articles and works closely with central office staff and cooperators to publish newsletters and report (technical and popular press).
- Performs data evaluation and assists with database management.
- Assists specialists at partner institutions with data and research needs.
- Develops materials for and gives presentations and reports to a wide range of audiences (including producer, industry, Federal government, and academic).
- Provides leadership for economic analysis and market outlook.
- · Provide critical Center administrative functions regarding personnel, budgets, and planning.
- Oversees enhancement and management of Center database system.
- Supports multi-state and multi-institution outreach efforts and program development.

- Maintains strong working relationships with livestock industry organizations and government agencies.

  agricultural commodity marketing and price analysis if transcripts do not clearly identify those specific courses, please
  highlight and describe applicable studies in application materials.
- Ability to analyze and integrate data and information from diverse sources.
- Experience or strong interest in U.S. agriculture and food systems.
- Demonstrated experience in working with individuals, groups, and staff (teamwork) to accomplish individual and/or group
  goals as indicated by experience and references.
- Evidence of drive and initiative as demonstrated by personal experiences and employment (must be a self-starter).
- Ability to communicate through teaching, public speaking/presentation and writing as demonstrated through application
  materials and experience, formal training, and publications.
- Demonstrated evidence of skills with computer applications (spreadsheet, database, word processing, website tools).
- Must have a valid driver's license or the ability to obtain a driver's license or access to a licensed driver by the
  employment start date.

- Experience with USDA data/information sources.
- Broad knowledge of management and policy issues in food and agriculture system.
- Experience regarding key countries that import and export meat and livestock to the U.S.
- Previous administrative and office management experience.
- Evidence of successful grant funding and grant program administration.
- Experience with websites for delivery of information and data and interest in using social media for educational outreach.
- Understanding of statistical analysis software.
- Leadership ability as demonstrated by experience and elected and/or appointed positions of responsibility.
- Knowledge and familiarity with Cooperative Extension and the Land Grant University system.
- Ability to speak Spanish.
