- Redesigned 'ANALYSIS SUMMARY' table to show 2014 payments in addition to the 2014-2018 total with optimal program selection under existing base and reallocation of base scenarios. Added footnote about assumption there is no payment reduction from excess FAV plantings.
- Redesigned 'ANALYSIS DETAIL: Payment per Base Acre' tables.

 The tables were expanded by one column to show difference between revenue guarantee and actual revenue to allow user to see how close ARC-CO is to generating a payout.

 Also, payment cells are blanked for crops for which the farm doesn't have base acres. This provides more clarity about which crops in the detail tables are relevant to the analysis.

 Lastly, a footnote will appear to identify years where ARC-CO payments are at the maximum.
