ATTENTION AERIAL APPLICATORS

North Dakota Administrative Code 60-03-01-5.1(4) requires that all aerial applicators seeking recertification must show proof of attendance at a Professional Aerial Applicators Support System (PAASS) program at least one time during the previous three years before recertification may be issued.

This means that if you have not attended the PAASS program at the Tri-State Aerial Applicators Convention in 2018 or 2019, you must attend the PAASS program this training season (2020).

Please note that the Safety Briefing sponsored by the North Dakota Aeronautics Commission is **not** a substitute for the PAASS program.

**North Dakota Commercial/Public/Dealer Pesticide Certificate Holder in:
Home, Industrial and Institutional; Public Health; Wood Preservation; and Vertebrate**

One or more of your pesticide categories will expire on April 1, 2020. To renew, attend a training or take the exam/exams, comply with the North Dakota Financial Responsibility Law and pay the certification fee. Refer to your current pesticide certification card to determine which category or categories will expire.

A training schedule for Public Health and Home, Industrial and Institutional for 2019-20 is on the back of this letter. Please note: Your Ground or Aerial/Ground Core status will update automatically; however, we do not address other categories at these trainings. If you have additional categories, you may be required to attend more than one training (or take the exams). You will receive information for other categories in a separate mailing.

Preregistration is required and must be received in our office by the deadline or you will pay a \$25 late fee. Trainings fill up fast, so preregister early. Do not order study materials if you will be attending a training; all materials needed will be provided on-site.

Home-study renewal is available for the Home, Industrial and Institutional; Public Health; Vertebrate; and Wood Preservatives categories. The home-study course must be completed and received in our office before April 1, 2020. After April 1, monitored exams may be taken at any NDSU Extension county office. You may order home-study courses at <https://tinyurl.com/ndsupesticide>.

Financial Responsibility reporting has changed. Financial Responsibility laws have **not** changed. You will no longer provide us with your financial responsibility documentation, i.e., insurance certificates and notarized letters. Instead, you need to be ready to provide that documentation upon request of a North Dakota Department of Agriculture inspector. **All** commercially certified persons (regardless of employer) will be required to complete an Applicant Acknowledgment of Proof of Financial Responsibility. This form will be distributed at the training or will be included in your home-study course. You can print a form from our website, <https://ndsupesticide.org>. Your certification will not be complete without the form on file in our office.
