Eligible applicants: Public entities with legal ownership or control of land where project is located

(counties, townships, cities, park districts, school districts, tribal equivalents)

All tree-planting projects must be located on public property.

Applicants must contact NDFS Community Forestry Staff to coordinate project planning efforts during the process of completing an application.

## **Grant Application Tips**

- Do a soil test to match tree species to site
- Plant a diversity of tree species
- Get assistance from resource professionals
- Provide photos of project site and a planting design plan
- Check the math on project budget page
- Submit ORIGINAL and 7 copies of application
