North Dakota County Business Establishments, Business Employees, and Payroll: 2006

The number of North Dakota business establishments with paid employees grew 5.9 percent from 2000 through 2006, according to a U.S. Census Bureau report, "County Business Patterns," which focuses on the number of single physical locations at which business is conducted. The 21,332 business establishments in the state employed 278,423 persons in mid-March 2006, up 9.1 percent from 255,178 persons in mid-March 2000. Total business payroll for the state was \$8.4 billion in 2006, up 38.7 percent from \$6.1 billion in 2000 (Table 1).




Figure 1. Employees of Business Establishments by Industry

Various service industries, along with retail trade, employ a large proportion of North Dakota's business work force. Health care and social assistance alone employed 18.4 percent in 2006. Accommodation and food services accounted for another 10.5 percent. The retail trade industry employed 16.1 percent of the state's business work force in 2006 (Figure 1).

Approximately half of all North Dakota counties experienced growth in the number of business establishments from 2000 through 2006 (28 of 53) (Figure 2).

Data in this publication exclude most government employees, railroad workers, and self-employed persons.




Figure 2. Numeric Change in Number of Business Establishments with Paid Employees in North Dakota by County: 2000 to 2006 Note: Establishment counts exclude most government agencies, railroads, and self-employed persons. Source: U.S. Census Bureau, County Business Patterns, www.census.gov/epcd/cbp/view/cbpview.html.

Numbers of North Dakota Business Establishments and Business Employees Grow in 2006

The number of North Dakota business establishments with paid employees grew 5.9 percent from 2000 through 2006. The 21,332 business establishments in the state employed 278,423 persons in mid-March 2006, up 9.1 percent from 255,178 persons in mid-March 2000.

This month's "Population Bulletin," a monthly publication from the North Dakota State Data Center at North Dakota State University, focuses on the number of North Dakota business establishments with paid employees, business employees, and annual business payroll as released by "County Business Patterns," a U.S. Census Bureau data series published annually. The data focus on the number of single physical locations at which business is conducted.

Total annual business payroll for the state was \$8.4 billion in 2006, up 38.7 percent from \$6.1 billion in 2000. Annual payroll per business employee averaged \$30,168 statewide in 2006, up 27.1 percent from \$23,737 seven years earlier. Inflation rose 17.1 percent during this time. Nationally, the annual payroll per business employee averaged \$39,965 in 2006, up 17.5 percent from \$34,011 in 2000.

Various service industries, along with retail trade, employ a large proportion of North Dakota's business work force. Health care and social assistance alone employed 18.4 percent in 2006. Accommodation and food services accounted for another 10.5 percent. Retail trade employed 16.1 percent of the state's business work force. Business employment followed similar trends nationwide, with health care/social assistance and retail trade industries representing the largest business employers in 2006 (13.7 percent and 13.1 percent, respectively). "What is surprising and noteworthy is the rapid rise in businesses without a fixed location," said Richard Rathge, Director of the State Data Center. "These businesses, which nearly doubled in number between 2000 and 2006, expanded their paid workforce by 114 percent over that time period. One possible reason for this growth is the emergence of employee leasing companies which may have client businesses in multiple counties," said Rathge.

Nationally, the number of business establishments grew 7.5 percent between 2000 and 2006. Nevada reported the largest percentage gain in businesses (27.0 percent), followed by Utah (24.2 percent), Idaho (22.2 percent), Florida (20.7 percent), and Arizona (20.1 percent). Four states reported losses (Ohio, Massachusetts, Michigan, and West Virginia). Approximately half of all North Dakota counties experienced growth in the number of business establishments from 2000 through 2006 (28 of 53).
