

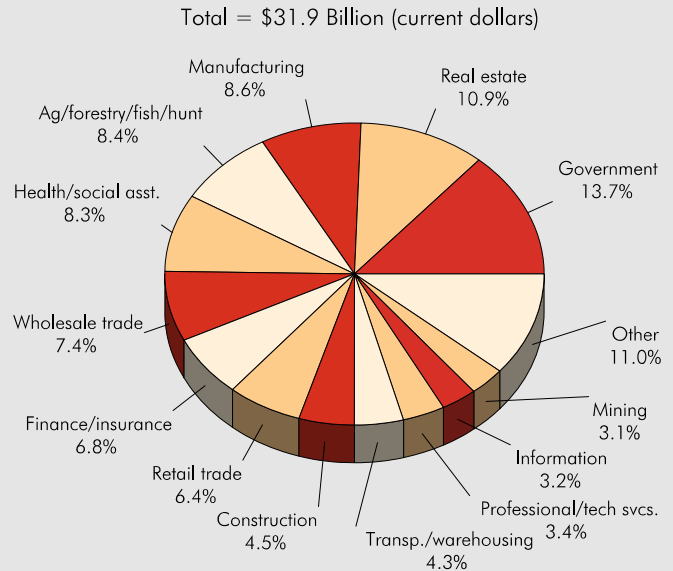
North Dakota Gross Domestic Product by Industry: 2009

North Dakota's current-dollar gross domestic product (GDP) grew to \$31.9 billion in 2009 (Figure 1 and Table 1), representing 0.2 percent of GDP nationwide. After adjusting for inflation, North Dakota's real-dollar GDP grew 4 percent from 2008 to 2009, the third fastest economic growth in the nation behind Oklahoma and Wyoming (Figure 2). In North Dakota, the government sector comprised 14 percent of total GDP in 2009. Real estate captured 11 percent of the state's total GDP, followed by manufacturing (9 percent), agriculture and health care (8 percent each), and wholesale trade and finance (7 percent each) (Figure 1).

According to the Bureau of Economic Analysis (BEA), GDP by state is the state counterpart of the nation's gross domestic product, BEA's featured measure of U.S. output. GDP by state is the value added in production by the labor and capital located in a state. In concept, an industry's GDP by state is equivalent to its gross output (sales or receipts and other operating income, commodity taxes, and inventory change) minus its intermediate inputs (consumption of goods and services purchased from other U.S. industries or imported).

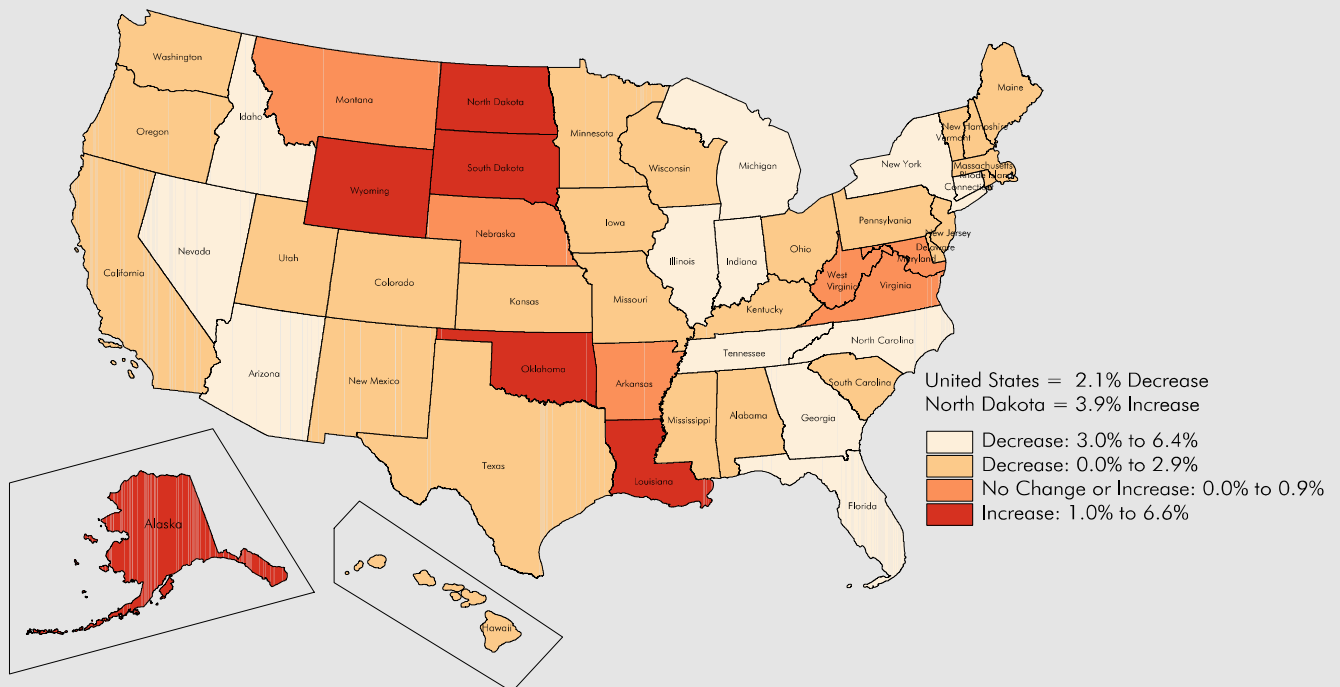

North Dakota Gross Domestic Product Reaches \$31.2 billion

The current-dollar gross domestic product (GDP) was \$31.9 billion for North Dakota in 2009. The government sector comprised 14 percent of North Dakota's total GDP. Real estate captured 11 percent of the state's total GDP, followed by manufacturing (9 percent), agriculture and health care (8 percent each), and wholesale trade and finance (7 percent each).

This month's "Economic Brief," a monthly publication from the North Dakota State Data Center at North Dakota State University, focuses on state gross domestic product by industry sector.

According to the Bureau of Economic Analysis, gross domestic product by state, considered the state counterpart of the nation's gross domestic product, is the value added in production by the labor and capital located in a state.

After adjusting for inflation, North Dakota's real-dollar GDP grew 4 percent from 2008 to 2009 - the third fastest economic growth in the nation behind Oklahoma and Wyoming. Agriculture, forestry, fishing and hunting was the leading contributor to real-dollar GDP growth in North Dakota, followed by wholesale trade, government, finance and insurance, and construction.

"What is impressive about our state's growth in GDP is that it took place during one of the worst recessions since the Great Depression. In fact, U.S. real GDP actually declined by 2 percent during this time period along with 36 states," said Richard Rathge, director of the State Data Center.

When combined, the four largest state GDPs (i.e., California, Texas, New York, and Florida) captured approximately one-third of the nation's total GDP in 2009. The two smallest state GDPs, North Dakota and Vermont, each captured 0.2 percent.
