

North Dakota Gross Domestic Product by Industry: 2010

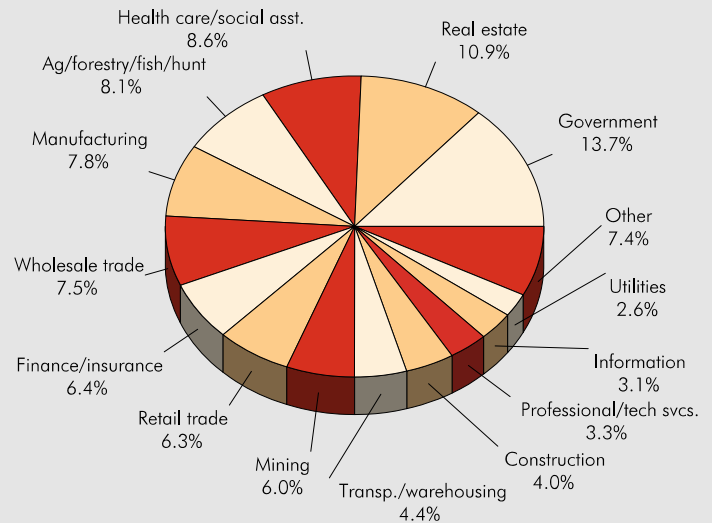
North Dakota's current-dollar gross domestic product (GDP) grew to \$34.7 billion in 2010 (Figure 1 and Table 1), representing 0.2 percent of GDP nationwide. After adjusting for inflation, North Dakota's real-dollar GDP grew 7 percent from 2009 to 2010, the fastest economic growth in the nation (Figure 2). In North Dakota, the government sector comprised 14 percent of total GDP in 2010. Real estate captured 11 percent of the state's total GDP, followed by health care (9 percent), agriculture and manufacturing (8 percent each), and wholesale trade (7 percent) (Figure 1).

According to the Bureau of Economic Analysis (BEA), GDP by state is the state counterpart of the nation's gross domestic product, BEA's featured measure of U.S. output. GDP by state is the value added in production by the labor and capital located in a state. In concept, an industry's GDP by state is equivalent to its gross output (sales or receipts and other operating income, commodity taxes, and inventory change) minus its intermediate inputs (consumption of goods and services purchased from other U.S. industries or imported).

Total = \$34.7 Billion (current dollars)

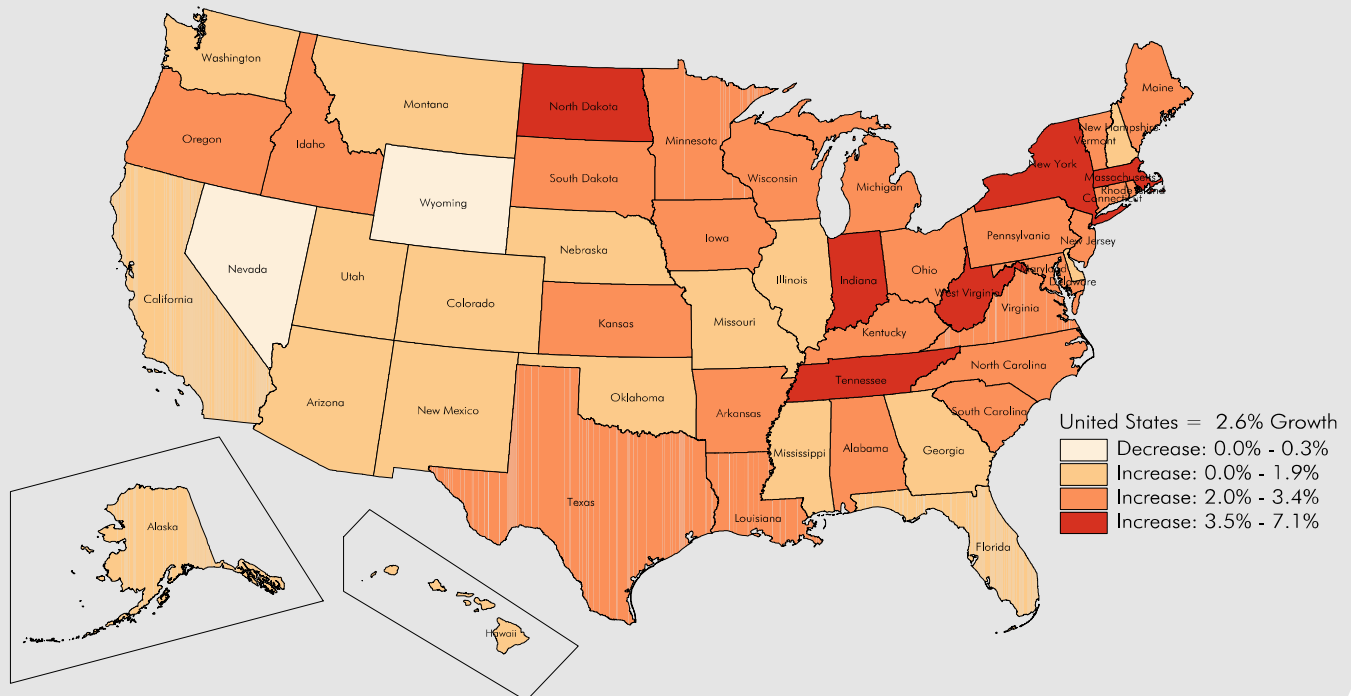

North Dakota Gross Domestic Product Reaches \$34.7 billion

The current-dollar gross domestic product (GDP) was \$34.7 billion for North Dakota in 2010. The government sector comprised 14 percent of North Dakota's total GDP. Real estate captured 11 percent of the state's total GDP, followed by health care (9 percent), agriculture and manufacturing (8 percent each), and wholesale trade (7 percent).

This month's "Economic Brief," a monthly publication from the North Dakota State Data Center at North Dakota State University, focuses on state gross domestic product by industry sector.

According to the Bureau of Economic Analysis, gross domestic product by state, considered the state counterpart of the nation's gross domestic product, is the value added in production by the labor and capital located in a state.

After adjusting for inflation, North Dakota's real-dollar GDP grew 7 percent from 2009 to 2010 - the fastest economic growth in the nation. Mining was the leading contributor to real-dollar GDP growth in North Dakota, followed by real estate and wholesale trade.

"Mining added nearly 2 percentage points to our state's real-dollar GDP growth of 7 percent from 2009 to 2010, demonstrating the large economic impact that energy development activities are having on the state. Our state's per capita GDP was \$46,336 in 2010, ranking us 12th highest in the nation compared to ranking 39th in 2000," said Richard Rathge, director of the State Data Center.

Real-dollar GDP increased in 48 states and the District of Columbia in 2010. Real-dollar GDP by state grew 2.6 percent nationally in 2010 after declining 2.5 percent in 2009.
