
Population by Race and Hispanic Origin in North Dakota: 2010 Census

In the 2010 Census, one-tenth of North Dakota's population reported their race as something other than White alone. This "racial minority" population increased from 49,019 to 67,142 from 2000 to 2010 (Table 1). This represents a growth of 37 percent over the decade (Figure 2). The White alone population also grew over the decade, from 593,181 to 605,449; however, growth was relatively slow for this population (2 percent).

The number of North Dakotans reporting American Indian alone, the state's largest racial minority, increased by 5,262 from 2000 to 2010 (i.e., a 17 percent growth). During the same time, the number of persons reporting Black alone increased by 4,044 (103 percent), and those reporting Asian alone increased by 3,393 (89 percent)(Figure 1).


Persons of Hispanic origin (an ethnic category reported separately from race) comprised 2 percent of North Dakota's total population in 2010 and grew by 5,681 (73 percent) from 2000 to 2010.

Nationally, the Hispanic population grew by 43 percent from 2000 to 2010.

North Dakota's Population Becoming More Racially and Ethnically Diverse

Although racial minorities in North Dakota continue to represent a relatively small proportion of the state's total population (i.e., 1 in 10), the racial minority population has grown by 37 percent over the past decade.

This month's "Population Bulletin," a monthly publication from the North Dakota State Data Center at North Dakota State University, presents the 2010 Census population counts by race and ethnicity.

In the 2010 Census, one-tenth of North Dakota's population reported their race as something other than White alone. This "racial minority" population increased from 49,019 to 67,142 from 2000 to 2010. This represents a growth of 37 percent over the decade. The White alone population also grew over the decade, from 593,181 to 605,449; however, growth was relatively slow for this population (2 percent).

The number of North Dakotans reporting American Indian alone, the state's largest racial minority at 5 percent of the total population, increased by 5,262 from 2000 to 2010 (i.e., a 17 percent growth). During the same time, the number of persons reporting Black alone increased by 4,044 (103 percent), and those reporting Asian alone increased by 3,393 (89 percent).

Persons of Hispanic origin (an ethnic category reported separately from race) comprised 2 percent of North Dakota's total population in 2010 and grew by 5,681 (73 percent) from 2000 to 2010. Within North Dakota, approximately half of the Hispanic population (i.e., an ethnic minority) identified themselves as White alone (i.e., a racial majority) in 2010.

"This can be confusing when talking about minority status because the Hispanic population is reported separately from race," said Richard Rathge, director of the North Dakota State Data Center.

If people reporting both White alone and Hispanic origin are included into the "racial minority" category discussed earlier, this "racial and ethnic minority" category in North Dakota grew 41 percent over the past decade, from 53,051 in 2000 to 74,584 in 2010.

Nationally, the "racial and ethnic minority" population (i.e., people who reported their ethnicity and race as something other than non-Hispanic White alone) grew by 29 percent from 2000 to 2010.
