Who must attend a Soil Fumigation Recertification Workshop in 2014? Minnesota pesticide applicators licensed in Categories A and O and who became licensed in O: Soil Fumigation for the first time in 2013 need to attend an MDA approved recertification workshop in 2014. MDA requires attendance at an approved O: Soil Fumigation recertification workshop once every two (2) years starting the year following the year of initial license in Category O. Attendance fulfills the recertification requirement in Categories A and O by licensed commercial and noncommercial pesticide applicators.

When do I renew my license, attend a recertification workshop, or retest? License renewal is required every year, and follows recertification. Attending this 2014 Recertification Workshop enables pesticide applicators to renew their license for A and O in 2015 and 2016. If an applicator does not attend a 2014 workshop in their categories as required, retesting must be completed before a license can be renewed. Then, in addition to the license application fee, retest fees are charged for each category.
