Class VI's Bismarck seminar kicked off with ND Commerce Commissioner AI Anderson speaking as well as Kevin Iverson, and Sandy McMerty from the ND Commerce Department. They shared with us business statistics, population trends and advice on using social media to connect and develop our communities. Several of the many things we learned is that North Dakota is the 4th youngest state, the #1 state for young adults and that we've had nearly 600% increase in exports. Lunch was sponsored by Annie White Carlson (RLND Class V) owner of Morning Joy Farms.

Matt Sagaser gave us a tour of the North American Innovation and Acceleration Center for Doosan and Bobcat brands.
