Fair – The fair will be the last week of June. If goats are not found by February 2019 then we will drop Goat Tying from the list of classes. If any changes are going to be made to the Fair book then they will need to be made by February.

Awards: Fly Sheet and Bronze statue for overall high point, Jackets and sweat shirts for Grand and reserve.

New rule books will be \$5; Stacey made a motion to buy a rule book for each 4-H family showing horses at the fair, 2nd by Kris. Motion carried.

Suzan made a motion to buy resource books for the extension office up to \$150, 2nd by Stacey Motion carried.

Carrie made a motion to give \$150 for Hippology entries to the Hippology team, 2nd by Kris Motion carried.
