The time commitment for the REND Program will be approximately 22 days the first year and 25 days the second year. In-state seminars are held January, February, March, June, and November for three, occasionally four, days. Seminars usually start around noon on Wednesday and conclude around noon on Friday. Travel time to and from these seminars is not included in the time commitment estimation.
	Undivided attention is required during seminar hours. Class members are required to adhere to the electronic device policy and refrain from working on electronic devices while seminars are in session unless their use pertains directly to the seminar. They may conduct outside business during free time.
	The RLND Council is firm that participants attend all seminars to graduate from the program.
